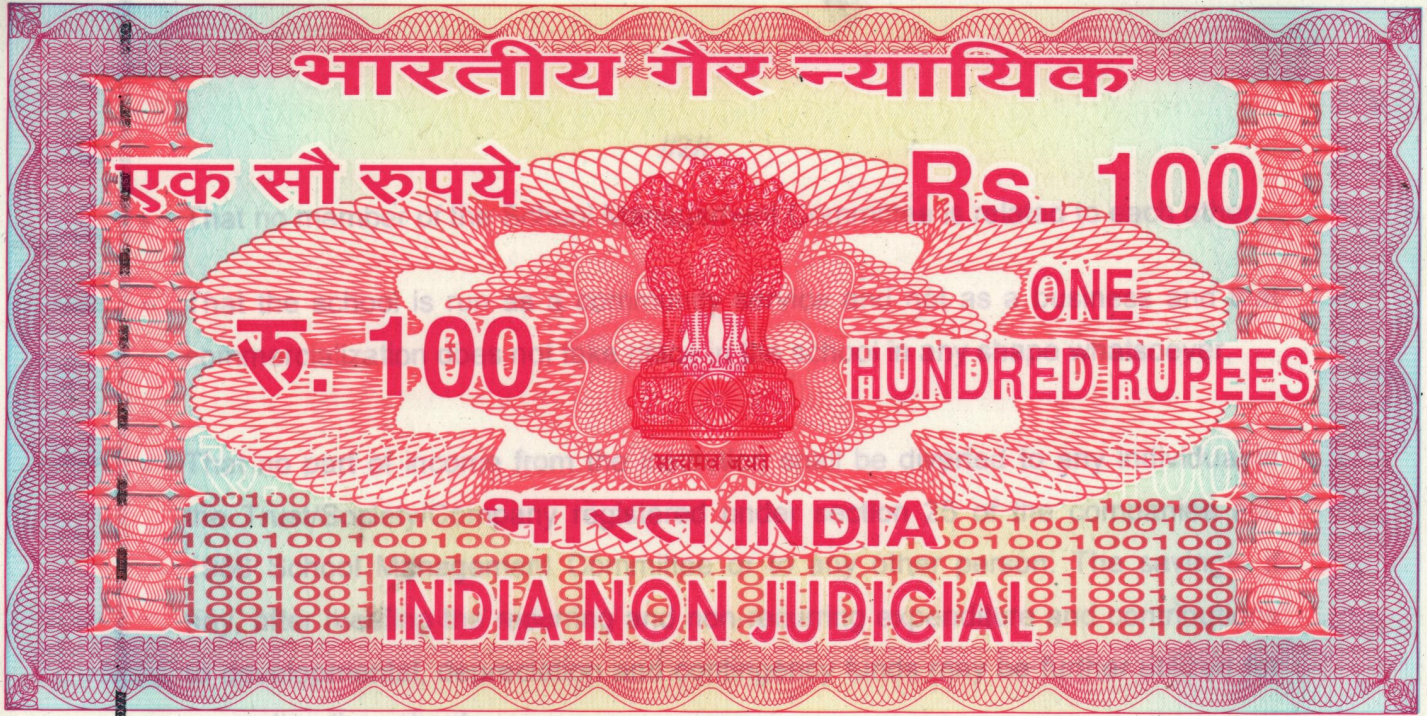

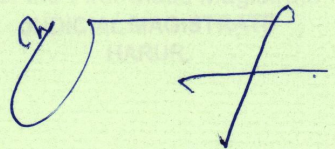
- That Sri Ram Educational and Charitable Trust is a registered Trust under the Indian Trust Act.
- That the Sri Ram Educational and Charitable Trust is of Non-Proprietary Character

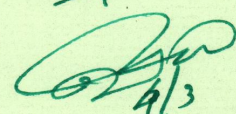
